## IF THIS CREDIT APPLICATION IS APPROVED, THE UNDERSIGNED AGREES AS FOLLOWS:

- 1. Payment.** All payments are to be made within NET 30 days of the invoice date. Payments in default will be assessed a service charge of 1.5% per month, compounded monthly. There will be a delinquency charge for each dishonored check of \$75. All payments are applied to unpaid delinquency and service charges, costs of collection (including attorney's fees) and the invoice amount(s) in the order solely determined by BIRDSALL despite any notation on or accompanying any payment.
- 2. Off-Road Damage.** Applicant accepts all responsibility for damage to vehicles or property when delivery is requested "off" public roads.
- 3. Collection.** In the event that this account is placed for collection, Applicant agrees to pay reasonable attorney and collection fees, the minimum to be no less than 30% of the uncollected balance and any court costs or fees that are incurred in connection with the collection of this account.
- 4. Deliveries.** The Construction Lien Law requires an authorized representative to be on site to accept and receive deliveries from BIRDSALL. We understand that this is not always practical or feasible. Applicant waives the requirement of having an authorized person present when deliveries are made and will not contest such deliveries. Applicant understands that any discrepancies in a delivery must be communicated in writing to BIRDSALL within twenty-four (24) hours following the receipt of delivery. If no such communication is made and BIRDSALL does not acknowledge in writing a discrepancy regarding such delivery, then the delivery will be irrevocably deemed to be accepted and Applicant will be obligated to pay for the same.
- 5. Litigation.** This Credit Application and Personal Guaranty and the sales transactions between the parties shall be governed by NJ law. No suit or action shall be commenced by Applicant and/or any Personal Guarantor relating to this Credit Application and Purchase Agreement or the Personal Guaranty or any product sold by BIRDSALL other than in the Superior Court of the State of NJ, in a County where BIRDSALL is located; and no such suit or action shall be commenced by Applicant or Personal Guarantor later than one year from the date of the delivery of the subject product. Applicant and each Guarantor irrevocably submits to the personal jurisdiction of that court and the service of process by certified mail, return receipt requested, and regular mail to the addresses indicated in this document or the last location identified in writing by Applicant and the Personal Guarantor to BIRDSALL, effective two days after such mailing.
- 6. LIMITED 90-DAY WARRANTY & DISCLAIMER.** All products sold by BIRDSALL are warranted for a period of 90 days from date of delivery to be free of defects that make the product not fit or serviceable for the normal use for which intended. BIRDSALL's only obligation and Applicant's only remedy for breach of this Limited Warranty, at the sole option of BIRDSALL, is to repair, replace, refund or credit the purchase price of the product or part found to be defective. **BIRDSALL HAS NO OBLIGATION OR LIABILITY FOR CONSEQUENTIAL DAMAGES ARISING OUT OF OR IN CONNECTION WITH THE USE OR PERFORMANCE OF THE PRODUCT OR FOR LABOR AND/OR OTHER MATERIAL COSTS USED TO REPAIR OR REPLACE ANY DEFECTIVE PRODUCT OR PART THEREOF WARRANTED HEREUNDER OR FOR ANY OTHER INDIRECT DAMAGES INCLUDING BUT NOT LIMITED TO LOSS OF REVENUES OR PROFIT. THERE ARE NO OTHER WARRANTIES, EXPRESS OR IMPLIED, OF MERCHANTABILITY, FITNESS FOR ANY PARTICULAR PURPOSE OR OTHERWISE RESPECTING ANY PRODUCT SOLD OR DELIVERED BY BIRDSALL.** At the conclusion of this 90-day Warranty, BIRDSALL shall be under no further obligation or liability.
